The Board is comprised of family members who have a loved one with a mental illness and other interested parties involved in the local mental health community. Our programs and activities include: NAMI Family-to-Family education classes offered 4-6 times throughout the year. NAMI Peer-to-Peer education classes for individuals diagnosed with a severe mental illness offered 4 times throughout the year. NAMI Basics education classes offered 2-3 times per year "Ending the Silence" presentation available to high schools upon request. In Our Own Voice presentations providing speakers to churches, schools, educational classes, health fairs and community events upon request. Providing 10 family and peer (Connection) support group meetings held throughout the County. Quarterly General Meetings for members and the public.
